Dharan-Leuti Road Tunnel Project





Background

The Dharan-Leuti section is a crucial segment of the Koshi Highway, forming part of Nepal's North-South corridor. It serves as a vital link between the Indian border at Biratnagar (Rani) and the Chinese border at Kimathanka. This project represents another significant step towards tunneling infrastructure development in Nepal. It is accessible from both ends of the Koshi Highway, with one end located on Dharan Side and the other on Dhankuta Side. The tunnel's alignment passes through the catchment areas of the Khardu and Dharapani Rivers. This project intends to shorten the travel distance along the Koshi Highway, thereby enhancing connectivity in the region.


